The Ministry of Human Resource Development (MHRD), Government of India (GOI), has established National Testing Agency (NTA) as an independent, autonomous and self-sustained organisation to conduct efficient, transparent and international standard tests in order to assess the competency of candidates.

University of Delhi (DU) has entrusted the responsibility of conduct of All India Entrance Examinations for admissions to UG, PG, M.Phil. and or Ph.D Courses to the NTA for the academic session 2019-20.

DUET-2019 shall be conducted by the NTA from 3rd July 2019 to 8th July 2019 in three shifts/ sessions viz. Shift 1: 8:00 a.m. – 10:00 a.m., Shift 2: 12:00 noon – 2:00 p.m. and Shift 3: 4:00 p.m. – 6:00 p.m. at more than 100 Examination Centres spread across 18 Cities. The examination would be conducted for various courses and programmes, based on the scheme of examinations and syllabi notified by the University of Delhi and defined in the Bulletin of Information available at the website of University of Delhi and National Testing Agency.

The Examination shall be conducted as Computer Based Test (CBT) only. The Test consists of Multiple-Choice Items only and is of Two (2) hours duration.

All the preparations for the fair and smooth conduct of exam have been completed.

- A Control Room has been setup at the headquarters of NTA.15 City Coordinators and 150 Observers have been positioned.
- A third-party audit of most of examination centres has been completed.
- Live CCTV- as done earlier, CCTV Surveillance will be started in 101 examination centres to curb malpractices in the examinations. The NTA has made arrangements for live viewing at remote locations and recording of CCTVs Systems of all examination centres at control room situated in the NTA.
- A network of more than 4000 Test Practice Centres, especially for students of rural areas, has run free practice sessions. About 10 lakh candidates have used the facility.
- Jammers- In order to stop cheating using mobile networks, approximately 3600 Jammers have been installed in all the Centres.

While assuring the candidates of the highest professional conduct of the exam, NTA requests cooperation of all the candidates for an orderly conduct of the exam.
