Candidates are required to pay online a sum of Rs. 1000/- (one thousand only) for each question challenged. The fee will be refunded if the challenge is found correct.

The facility to view question paper and responses will also be available **till 05.12.2019 (upto 11:50 PM)**.

Procedure for Challenge of Answer Key

- 1. Please go to website: https://iift.nta.nic.in
- 2. Click on 'Challenge(s)regarding Answer Key'
- Login with your Application Number and Date of Birth and enter Security Pin as displayed and Submit.
- 4. Click to 'Challenge Answer Key' button.
- 5. You will see **110 Questions IDs.** They are in sequential order.
- 6. The ID next to the question under the column 'Correct Option (s)' stands for the correct Answer Key to be used by NTA.
- 7. If you wish to challenge this option, you may use anyone or more of the Option IDs given under option(s) ID claimed by clicking the check box.
- 8. After clicking your desired option, scroll down, 'Save your Claim(s)' and move to next screen.
- 9. You will see a display of all the **Option IDs** you have challenged.
- 10. You may want to upload supporting documents, you can select 'Choose File' and upload (all documents to be put in a single pdf file).
- 11. Click on 'Save your Claim and pay fee'.
- 12. You will find a screen displaying your challenges.
- 13. Kindly pay the processing fee by clicking on 'Pay Fee'.
- 14. Select Mode of Payment and Pay your processing fee @ Rs.1, 000/- for each question challenged. Make payment through Debit/Credit Card/Net Banking.
- 15. In case your challenge is found correct, your processing fee will be refunded in the same account.
