Declaration of results of the Jawaharlal Nehru University Entrance Examination- (JNUEE) -2020

National Testing Agency (NTA) held the JNUEE 2020 during 5th October to 8th October 2020 for admission to various courses, offered by JNU for the academic year 2020-21.

The exams were held in the Computer Based Test (CBT) mode. The test was of objective type, comprising Multiple Choice Questions (MCQs).

A separate exam was also held for COVID-19 candidates on 28th October 2020 in 6 disciplines.

The exams were held in the following disciplines in English medium only (except language courses).
