Display of Provisional Answer Keys and Question Paper with Recorded Responses for Answer Key Challenge for CMAT-2021.

The **Common Management Admission Test (CMAT)-2021** was conducted throughout the country on **March 31, 2021** through the Computer Based Test (CBT) mode.

The National Testing Agency has uploaded the Provisional Answer Keys along with the Question Papers with Recorded Responses on the CMAT <a href="https://cmat.nta.nic.in">https://cmat.nta.nic.in</a> for candidates to challenge. The procedure (as enclosed for the challenge of Answer Key may be used.)

The candidates, who are not satisfied with the answer key, may challenge the same by paying a fee of ₹ 1000/- per question challenged as a non-refundable processing fee. This facility is available from April 3, 2021 to April 5, 2021 (upto 05:00 PM).

The payment of the processing fee may be made through, Debit Card/Credit Card/Net Banking/Paytm upto **April 5, 2021 (upto 11:50 PM).** No challenge will be entertained without receipt of the processing fee.

Challenges made by the candidates will be verified by the subject experts. If found correct, the answer key will be revised accordingly. Based on the revised Final Answer Key, the result will be prepared and declared. No individual candidate will be informed about the acceptance/non-acceptance of his/her challenge. The key finalized by the Experts after the challenge will be final.

## **Procedure for Challenge of Answer Key**

- 1. Please go to website https://cmat.nta.nic.in.
- 2. Click 'Challenge (s) regarding Answer Key'.
- 3. Log in with your Application Number and Date of Birth and enter Security Pin as displayed and Submit.
- 4. You will see Question IDs for CMAT – 2021 in sequential order:

Sr. No	Section
1	Quantitative Techniques and Data Interpretation
2	Logical Reasoning
3	Language Comprehension
4	General Awareness
5	Innovation and Entrepreneurship (Optional)

- 5. The ID next to the question under the column 'Correct Option' stands for the Provisional Answer Key to be used by NTA.
- 6. If you wish to challenge this option, you may use any one or more of the Option IDs given in the other columns by clicking the check box.
- You may choose to upload supporting documents, in that case you can 7. select 'Choose File' and upload (all documents to be put in a single pdf file).
- 8. After clicking your desired option scroll down, 'Save your Claim' and move to next screen.
- 9. You will see a display of all the **Option IDs** you have challenged.
- 10. Click on 'Save your Claim and Pay Fee Finally'.
- 11. Select Mode of Payment and Pay a non-refundable processing fee @ ₹ 1000/- for each question challenged. Make payment through Debit/Credit Card/Net Banking/Paytm.
