Inviting Online Applications for National Entrance Test for Scheme for Residential Education for Students in High Classes in Targeted Areas (SHRESHTA (NETS))-2022

Ministry of Social Justice and Empowerment has entrusted the responsibility of conducting National Entrance Test for Scheme for Residential Education for Students in High Classes in Targeted Areas (SHRESHTA (NETS))-2022.

Scheme for Residential Education for Students in High Classes in Targeted Areas (SHRESHTA) provides for high quality education for meritorious Scheduled Castes (SCs) students only, in CBSE-affiliated reputed residential schools. Approximately 3,000 seats would be provided in class 9th and 11th fully funded by the Central Government.

The National Entrance Test for SHRESHTA (NETS) will be an offline test conducted by the National Testing Agency (NTA) for selecting SC students for admission in Class 9 and 11 whose parental annual income is up to \gtrless 2.5 lakh. There is no fee for the examination.
