Declaration of result of Joint Integrated Programme in Management Admission Test (JIPMAT) – 2022.

National Testing Agency (NTA) Conducted Entrance Examination for Joint Integrated Programme in Management Admission Test (JIPMAT) – 2022 on **03.07.2022** for Admission to Integrated Programme in Management in IIM Bodh Gaya and IIM Jammu.

The exam was held in the **Computer Based Test (CBT) mode**. The test was of objective type, comprising Multiple Choice Questions (MCQs).

The exam was held in **78 Cities** across India at **60 Centres** for admission to the above-mentioned Programme.

The exam was conducted taking all necessary precautions, observing social distancing, sanitization, staggered entry of candidates into the exam hall, provision of masks to candidates, etc, laid down by the Govt. of India.
