The candidates are allowed to make the corrections, latest by 08 April 2022 (up to 09:00 P.M.). Thereafter, no correction in particulars, whatsoever, will be entertained by NTA under any circumstances. The additional fee (wherever applicable) shall be paid by the candidate concerned either through **Credit/Debit Card/Net Banking/UPI and PAYTM**. Since, it is a one-time facility extended to the candidates to avoid any hardships to them, the candidates are informed to do the correction very carefully, as no further chance for correction will be given to the candidates.
