Subject: Declaration of the Result/NTA Scores for the Joint Entrance Examination [JEE (Main) - 2025] of Paper 1 (B.E. / B.Tech.) – reg.

The Department of Higher Education, Ministry of Education, Government of India has entrusted the responsibility of conducting the Joint Entrance Examination (Main) to the NTA from 2019 onwards.

For Academic Session **2025-26**, NTA conducted the **JEE (Main) – 2025** in **two Sessions** i.e. Session 1 (January 2025) and Session 2 (April 2025) as per the details given below:

Paper 1 (B.E. / B.Tech.) was conducted in the **CBT (Computer-Based Test)** mode. JEE (Main) 2025 Session-1 examination was conducted in ten shifts and Session-2 was conducted in nine shifts.

The Examination was held in **13 languages (Assamese, Bengali, English, Gujarati, Hindi, Kannada, Malayalam, Marathi, Odia, Punjabi, Tamil, Telugu, and Urdu)**.

The JEE (Main)–2025 Session 2 was conducted at 531 unique examination centres in 300 Cities [including 15 cities outside India in **Manama, Doha City, Dubai, Muscat, Riyadh, Sharjah, Singapore, Kuwait, Kuala Lumpur, Kathmandu, Abu Dhabi, West Java, Washington, Lagos and Munich**].

The percentile of candidates appearing in various shifts of the JEE (Main)–2025 Session 2 are calculated as per the above formula and is being declared today.

Various measures were adopted by NTA for smooth conduct and monitoring of examinations as under:-

- The JEE (Main) being one of the most sensitive examinations, NTA made **elaborate arrangements at various levels** and took help from State and District Authorities for the smooth conduct of the examination.
- Pre-examination centre audit for a few new examination centres identified for conduct of JEE (Main) 2025 Session 2 was carried out by a third-party audit agency.
- For the centres outside India, **close coordination was done with the Embassy of India / High Commission of India** in those countries.
- Special emphasis was made on the **random deployment of exam functionaries** in all centres.
- Orientation training programme was conducted for all the examination functionaries in online mode for three consecutive days before start of the examination. A total of approximately 1100 exam functionaries and stakeholders attended the orientation training session.
- **283 City Coordinators, 858 Observers and representative of certain Government Cyber Security agencies** were deputed for examination duties in various cities and centres.
- A Central Control Room was opened at NTA to monitor and facilitate the smooth conduct of the Examination on the ground. The NTA also made arrangements for live viewing of remote locations of all examination centres from the Control Room located in the NTA premises of New Delhi.
- In order to stop cheating using mobile networks, Jammers were installed in all the Centres to prevent unfair practices by the candidates during the examination through mobile or any other electronic device. The latest **5G Jammers** were installed at all examination Centres.
- The examination centres were monitored using **AI-based Video Analytics** and Virtual Observers.

- **Live CCTV Surveillance** was planned in all examination centres to curb malpractices in the examination.
- Recording of CCTV Systems was also done and used for post examination analysis for identifying act of malpractices.
- **Unfair Means.** In Session-1, the NTA Scores of 39 candidates were not declared as they were found to have indulged in unfair means practices. During Session-2, a total of 110 candidates were similarly found to be involved in Unfair means including forgery of any document related to examination, and consequently, their results have not been declared. In addition to this, the results of 23 candidates have been withheld due to discrepancies in their photographs, biometric details or other personal information for identity verification. These candidates have been asked to provide a valid proof of their photographs duly attested by a Gazetted officer to NTA within a specified date for their results to be declared.
- **PwD/PwBD Committee.** The National Testing Agency (NTA) constituted a PwD/PwBD committee in coordination with the Department of Empowerment of Persons with Disabilities (DEPwD) and implemented the policies as per RPwD 2016 and guidelines for writing examinations by Persons with Disabilities.
- The PwD/ PwBD candidates were allotted to a **PwD/PwBD-friendly test Centre** and extra organizational support was given to those candidates.
- The **candidate's particulars** including Category and Person with Benchmark Disability (PwBD) have been indicated as mentioned by the candidate in the online Application Form.
- The **identity proof** as mentioned by the candidate in online application form was included in the admit card of the respective candidate for verification at the examination centre during biometric attendance.
- To make the candidates and their parents aware of the rules and regulations of the examination the “**Important Advisory and Instructions to the candidates for JEE (Main) - 2025**” were included in the Admit Card.
- Apart from the biometric attendance and frisking at entry, candidates were **frisked, and biometric attendance was taken again** on entry from the bio-break/toilets break.
- **Bio-breaks** were not allowed during the first hour and the last half an hour before the end of the examination.
- In order to make the examination system transparent, the Question Paper and recorded responses along with the Answer Key were displayed on the website for verification by examinees. After verification by the Subject Experts, the Final Answer Keys were published on the website.


